SUBJECT: SUPPLY, AT THE “V. FLORIO” TRAPANI – BIRGI AIRPORT, OF N. 1 PASSENGER WITH REDUCED MOBILITY (PRM) STAIRCASE, WITH SOLAR TRACTION ENGINE.

MARKET SURVEY – REQUEST FOR QUOTE

We hereby invite you to submit your best economic offer to carry out the supply in subject, having identical characteristics or with performance and functional equivalence or even improvements, compared to what is indicated below:

- 1) Embarkation/disembarkation of passengers with reduced mobility (PRM);
- 2) Solar traction engine to allow approaching aircraft (solar powered).

In particular, the ramp must not have steps, with non-slip flooring and must guarantee safety in dry and wet conditions.

Trapani – Birgi Airport operates mainly on Narrow-body class aircraft, with embarkation/disembarkation heights of 1.90 m. and maximum height 3.40 m.

Further minimum technical characteristics must be:

- Extendable Docking Platform;
- LED Walkway Lighting;
- Extra wide boarding/disembarking platform (Extra Wide Platform) minimum width 1.80;
- Orange Flashing Beacon;
- Proximity sensor;
- Safety stabilizers (Solid Wheels);
- Aircraft Approach Lighting.

The offer commits the supplier to the following additional activities:

- Delivery of the use and maintenance manuals;
- Possession of the CE Certification of the proposed vehicle;
- Possession of IATA AHM 913 conformity of the proposed vehicle;
- Airport operator training included.

Any interested supplier as producer and/or distributor of products with identical or equivalent characteristics to the specific intended use compared to that indicated above is therefore invited to express to this contracting body interest in awarding the supply in question, sending an economic offer.

The technical documentation relating to the marketed and proposed product must be attached, such as to allow this contracting body to understand the characteristics clearly and completely.
